

ACCRA recently released its' Cost-Of-Living Index report that provided the average annual data for the

In the annual report, nine metropolitan statistical areas were included in the Alabama data, with Dothan reporting the lowest composite index in the state at 87.1 percent.

The composite index is based on six components -Grocery Items, Housing, Utilities, Transportation, Health Care and Miscellaneous Goods and Services. Out of the six, the Dothan MSA also had the lowest index in three categories: Utilities 87.0, Health Care 83.1 and Miscellaneous Goods and Services 87.8 percent.

The ACCRA Cost of Living Index is published quarterly by C2ER - The Council for Community and Economic Research. The Index measures regional differences in the cost of consumer goods and services, excluding taxes and non-consumer expenditures, for professional and managerial households in the top income quintile. It is based on more than 50,000 prices covering almost 60 different items for which prices are collected quarterly by chambers of commerce, economic development organizations or university applied economic centers in each participating urban area. Small differences should not be interpreted as showing a measurable difference.

Every two years, the Alabama Department of Labor estimates the projected job growth in the region by occupation. They make projections on high-demand occupations and fast-growing occupations. High-demand is probably more relevant when seeking employment within the region as fast-growing occupations do not necessarily entail large number of jobs, and thus may not also be high-demand.

The following table sorts the regional demand for occupations by average number of annual openings. The period reflected is 2012 to 2022 and the table shows the 2012 occupational level and projected growth out 10 years. The health care occupations dominate this list as seen by the yellow highlighting.

DOTHAN AREA CHAMBER OF COMMERCE 2015 STATE AND FEDERAL LEGISLATIVE AGENDA

State Issues

- Support strong economic development incentives that enhance state and local empowerment to assist with new and existing industrial business, and do not exempt educational taxes as passed in the 1992 tax incentive reform;
- Support legislation specific to the Low Income Housing Tax Credit Section 42 program that bases property appraisals on income generated to assess property instead of replacement or market approach; and
- Support legislation to exempt the sale of farm equipment from state sales tax.

Federal Issues

- Support the long-term solvency of the Federal Highway Trust Fund and continued support of limited access highway development in Dothan and the Wiregrass area:
- Support Federal Aviation Administration's entitlement funding program for commercial airports and the contract tower program which is vital to the Dothan Regional Airport;
- Support strong funding levels for federal programs important to community and economic development including the Community Development Block Grant Program, Economic Development Administration, and the United States Department of Agriculture Rural Development Program;
- Monitor sequestration, defense cuts, and/or Base Closure and Realignment Commission to ensure there is no negative impact on Ft. Rucker to the fullest extent possible;
- Support the Marketplace Fairness Act which grants states the authority to compel on-line and catalog retailers to collect sales tax at the time of transaction just like local businesses are required to do; and

In this month's message, I would like to share more information on the Dothan Area Chamber of Commerce's Economic Development Council, and strategic Goal One of five - Grow the

Economy of the Wiregrass.

The Economic Development Council is chaired by past Chairman, Mark Saliba, president of Alfred Saliba Corp. and who is extremely involved in numerous community activities. Matt Parker, our Chamber president and lead economic developer, is one of the most respected economic developers in the state of Alabama with over 25 years of experience and a myriad of successful project agreements. Mike McIntyre. Saliba, Parker and Mitchell, along with Dothan Mayor Mike Schmitz and Houston County Chairman Mark Culver, form a united and capable economic development team.

The Chamber plays an important role in the life of small and large businesses. You may have heard the expression, a rising tide floats all boats ... small and large. So the Chamber's economic development efforts are crucial. In October, Grow Dothan Chairman Saliba, along with Mayor Schmitz and Chairman Culver, announced the launch of a Grow Dothan Capital Campaign. Just a couple of months ago, Michelin North America Inc.'s Plant Manager, Marcel Leclerc, visited with the Chamber's Board of Directors to present the organization a plaque in honor of our long-standing partnership. According to Leclerc, Michelin Dothan is celebrating its 35th year in Dothan, which is one of the global organization's most productive plants.

Another company, U.S. Coupling and Accessories Inc., moved to Dothan in 2006 and has been growing and expanding yearly. Starting with 18,000 square feet, Bob and Cathy Gourlay and their employees now utilize 40,000 square feet and are an industrial leader in supplying coupling attachments for fire and agriculture hoses and the fracking industry. Bob Gourlay summed up the pro-business environment that the Wiregrass city, state and business leaders have advocated for years when he told the Dothan Eagle last year, "Up (North), the regulations, taxes and all the requirements are just crushing to a business, whereas down here they keep it simple. They're just as effective, but they don't create a lot of nonsense."

And consider success stories like Jennifer Ford, president of the newly created business Ford Finders Employment Services. Ford's passion for adults with special needs and her experience connecting people to work, led her to branch out on her own and start a new business. Her wide network of Chamber friends

was there to support her during her transition, and to celebrate with her at the recent Ford Finders ribbon cutting. Ford has been an active volunteer with the Chamber for many years, and in fact was named the Chamber's 2014 Star of the Year.

Second, as for recruiting, the Dothan Area Chamber has been heavily involved in recent successes like Commercial Jet Services, LLC, Alabama College of Osteopathic Medicine and Glasstream Powerboats, LLC. The Chamber, along with the city and county, is actively pursuing new national and international opportunities. The U.S. - China Manufacturing Symposium put the Wiregrass in the spotlight for job creation; recent business development trips to China and Korea have been productive; and we are maximizing our efforts across the globe.

And third, infrastructure. The recently announced Alabama-Florida Mega Site Project is a joint effort by 12 counties in southeast Alabama and northwest Florida to lure a large manufacturer to a 2,240 acre industrial site in Campbellton, Florida. Having this mega site now puts us in the game to lure high-wage workforce opportunities for the entire region. Just south of State Highway 2 and east of U.S. Highway 231, and just 14 miles from Interstate 10, the site includes a strong combination of man-made and natural resources.

Growing the economy of the Wiregrass is the number one priority of the Chamber and our economic development team. Creating and sustaining good jobs is the most powerful way that we can positively impact our community.

The Small Business Administration's Office of Small Business Advocacy does a Small Business Profile each year. According to the 2013 profile:

- There were 386,661 small business;
- There were 71,279 small businesses with employees;
- There were 315,382 small businesses without employees (non-employers); and
- There were 764,207 workers employed by small businesses.

State Economy Overall:

- Alabama's economy grew at a slower rate than the United States in 2013. Alabama's real gross state product increased by 0.8 percent compared to 2.2 percent for U.S. gross domestic product. (Source: Bureau of Economic Analysis)
- The employment picture in Alabama has remained constant. The unemployment rate in Alabama stayed the same at 6.3 percent in October 2013 to 6.3 percent in October 2014. This is above the national average of 5.8 percent for the same time period. (Source: Bureau of Labor Statistics)

Employment:

- Alabama's small businesses employed about half or 764,207 of the state's private workforce in 2012. (Source: Statistics of United States Businesses)


